CIRCULAR

Subject: Grant of Enhanced Rate of Children Education Allowance to Officers/Officials of AIIMS, Rajkot

Reference:

In accordance with the instructions issued by the Government of India, Ministry of Personnel, Public Grievances and Pensions, the following revision of Children Education Allowance (CEA) and Hostel Subsidy rates is hereby communicated for officers and officials of AIIMS, Rajkot:

1. Revised Rates of Children Education Allowance (CEA) and Hostel Subsidy:

Sr. No	Particulars	Existing Rates (Rs.) (per month fixed rate)	Revised Rates (Rs.) (per month fixed rate)
1	School/Tuition Fees	2,250/-	2,812.5/-
2	Hostel Subsidy	6,750/-	8,437.5/-
3	Disabled (Divyaang) Children	4,500/-	5,625/-

2. Conditions:

- The rates mentioned above shall be applicable subject to the conditions laid down in the **OM No. 33 (2021/22) dated 13th July 2021 issued by AIIMS, Rajkot.**
- The CEA and Hostel Subsidy is admissible in respect of children studying form **three classes before class one** to 12th standard (irrespective of nomenclature of class) and also for the initial two years of a diploma/certificate course from Polytechnic/ITI/Engineering College, if the child pursues the course after passing 10th standard and the Government servant has not been granted CEA/hostel subsidy in respect of the child for studies in 11th and 12th standards.

3. One-Time Relaxation:

- A **one-time relaxation** is granted for reimbursement of CEA/Hostel Subsidy for employees whose children are required to **repeat one additional class due to the implementation of the New Education Policy 2020.**

4. Effective Date:

- The revised rates for CEA and Hostel Subsidy shall be applicable with effect from **1st January 2024.**
